OUR VISION IS TO IMPROVE ACCESS TO, AND UTILIZATION OF QUALITY HEALTHCARE SERVICES TO REDUCE THE RISK OF MATERNAL AND NEONATAL MORTALITY IN REMOTE RURAL AREAS WHERE MOTHERS AND THEIR NEWBORNS ARE MOST VULNERABLE. AS SUCH, OHW SPECIALIZES IN IMPROVING THE ACCESS TO, AND THE DELIVERY OF ESSENTIAL HEALTHCARE SERVICES IN REGIONS WHERE THE NEED IS THE GREATEST. WE WORK IN REMOTE AREAS WITH THE LOWEST HUMAN DEVELOPMENT INDEXES, WHERE OTHER ORGANIZATIONS RARELY OPERATE.
